



## MTAP Project Steering Group

The MTAP Project Steering Group (PSG) has oversight responsibility for the MTAP program. Ten member state representatives are elected by their peers to serve three-year terms. A PSG Chair and Vice-Chair are selected every two years.

### PSG Responsibilities

*What does the PSG do?*

- Provides the national MTAP organization with guidance on priority needs in the areas of:
  - national technical assistance projects for product development
  - peer to peer information exchange as based on input from MTAP-sponsored meetings
  - overseeing the quality and distribution of MTAP services and products
  - promoting MTAP to states and other relevant organizations

*How often does the PSG meet?*

The Project Steering Group meets through monthly conference calls. In-person steering group meetings are held twice a year in July and November or December.
